## **SECTION 2: Hazards identification**

**2.1 Classification of the substance or mixture:** This product is not hazardous classified. In accordance with regulations in force, the product does not present any risk for the health or for the environment.

### **SECTION 4: First aid measures**

#### **4.1 Description of first aid measures:**

- **Inhalation:** Remove to fresh air. Seek medical advice if symptoms persist.
- **Skin contact:** Wash with soap and water. Seek medical advice if irritation develops.
- **Eye contact:** Rinse immediately with clean water for several minutes. Seek medical attention if irritation continues.
- **Ingestion:** Rinse mouth. Do not induce vomiting. Seek medical attention if unwell.

- Keep away from moisture and incompatible substances.
- Keep the product in its packaging, well closed in a well-ventilated and dry place far away from dry. To avoid dust, keep the product closed.

### **8.1 Parameters Of Controls:**

- **Clay:** Exposition Limits: 4 mg/m<sup>3</sup> (Inhalable fraction), 0.9 mg/m<sup>3</sup> (alveolar fraction), VME – 8hours, Decree N°2021-1763 of 23rd December, 2021  
For ambient and individuals' exposures controls, these following methods are recommended:
- Decree of 15th December 2009 on roadworthiness tests of occupational exposure limit values at work and on the conditions for accreditation of bodies responsible for inspections.
- CIRCULAR DGT 2010/03 of 13th April 2010 on the control of chemical risks in the workplace. These methods are applicable in France. If you are in another country of the European Union or outside of the European Union, please contact the competent authority.
